

Objectives

- While the previous conferences focused on education, information and knowledge building, action steps for new and innovative methods of grassroots community-based treatment, development of new access points, community participation in native healing therapies, and emphasized early prevention and intervention for youth, this conference will focus on Raising Awareness, Tacking Action, and Saving Lives for individuals and families who suffer from addiction.
- Participants will discuss a variety of issues related to the opioid crisis, such as the principles that oversee the implementation of a trauma, stigma and substance misuse techniques. How to respond to behavior that motivates positive changes, and why professionals in health care, courts, social services, educators, human services, local and surrounding communities become more pro-active in the care of individuals suffering from substance misuse and addiction.
- This conference will explore the importance of culture and its impact on abstinence rates including an examination of examples of therapeutic models in correlation to cultural components. Through participation in this conference, clinicians and audience members will develop awareness of personal bias, understanding of minority groups' unique identities, and opportunities to navigate through challenges. Participants will gain confidence in their treatment approaches and practices in opioid related conditions and further knowledge and understanding when working with minorities. The conference will provide education on how to prevent suicide through education, advocacy, connection to resources, and support for those impacted by suicide.

This conference will benefit HTW, behavioral health and victim service providers, law enforcement, health care professionals (physicians, nurses, advanced clinical practitioners, physician assistants, social workers, nurse practitioners), educators, community organizers, human service workers, court personnel, therapists, addiction and recovery specialists, and students.
